#### Initial Statement of Reasons

## Title 13, Division 1, Chapter 1

#### Article 2.0 – Driver Licenses and Identification Cards

This proposed action amends the requirement that an applicant appear in person at a field office to submit a Gender Category Request, form DL 329S, in order to change their gender category on a previously-issued federal non-compliant driver's license or identification card. The department has made significant upgrades to allow for several transactions to be facilitated online using the department's online verification processes. This proposed action will allow customers an alternative, convenient method by which to change the gender category on their driver's license or identification card.

The department currently issues driver's licenses and identification cards that do not comply with the REAL ID requirements. Vehicle Code section 12801.5 establishes the requirements for driver's licenses and identification cards that do not comply with the REAL ID requirements. Vehicle Code section 12801.9 establishes the requirements for applicants who are unable to provide proof of legal presence, also known as AB 60 driver's licenses. Only applicants holding driver's licenses and identification cards issued under Vehicle Code section 12801.5 and driver's licenses issued under Vehicle Code section 12801.9 are authorized to submit their gender category change electronically.

## §20.05. Gender Categories.

The purpose of Section 20.05 is to identify the process by which an applicant can change the gender category identified on their driver's license or identification card. Currently, the options are male (M), female (F), or nonbinary (X). Section 20.05 requires an applicant to facilitate a gender category change by completing a Gender Category Request, form DL 329S, and submitting the form to a field office. This proposed action modifies the gender category change process by eliminating the form DL 329S.

The department proposes to adopt subsection (a) requiring the applicant to self-certify their chosen gender using the driver's license application. This new process will allow an applicant to submit the gender change online rather than having to visit a field office. When creating an online account, the applicant must complete an identity management segment that requires information that only the actual cardholder will have. Once the online account is created, an applicant will submit the gender category change using the driver's license and identification card application in the department's online portal. The information solicited from the applicant is consistent with the information contained on the form DL 329S including the name, date of birth, driver's license or identification card number, address, and an indication of the preferred gender category. The applicant's information will be verified and then the gender change request is accepted. This online verification process makes it unnecessary for the applicant to submit a form in person at a field office. This provision is necessary as it allows applicants a

more convenient method by which to change the gender reflected on their driver's license or identification card.

Subsection (a)(1) is adopted to make clear that an applicant who holds a REAL ID driver's license or identification is required to complete the transaction in person. The applicant can provide their information through the department's portal, however, the transaction will not be complete until they appear in person at either a department field office or with an approved business partner. This provision is necessary to ensure compliance with federal rules requiring a substantive change to a REAL ID to be completed in person.
