

## CERTIFICATION OF LIEN SALE FOR VEHICLE OVER \$4000 OR FROM A SELF-SERVE STORAGE FACILITY CIVIL CODE §3071

## NOTE TO THE LIENHOLDER:

This vehicle must be kept in your possession for a 10-day redemption period after the sale. If the vehicle is not redeemed, complete this form and give it to the buyer. Retain a copy to submit to DMV with any excess fees. If the vehicle is not sold because a qualifying bid was not received, the lienholder becomes the buyer indicated on the Certificate of Sale section. When this vehicle is sold, complete a bill of sale and give both forms to the buyer, remove and destroy the vehicle's license plate(s), and within 5 days of sale, submit a completed Notice of Release of Liability (NRL) form to the department. All registration fees and penalties become due and payable on the lien sale date.
